



Bagged and ready to use machine-applicable gypsum based plaster. Directly applied onto materials such as brick, fair faced concrete, gas concrete, pumice concrete, etc. Less plaster is used for the same coverage thanks to its special formula. The surface is ready for painting after only one coat. Does not require satin plaster skim. Can be manually applied with no difficulty onto intricate architectural details of door and window tympana. Attains high surface hardness and a brilliant surface. Since it is a breathable material, by balancing moisture **ALÇITEK GOLD** leads to a healthier environment. It is non-combustible. The water in its structure helps retard fire. **ALÇITEK GOLD** is a GREENGUARD certificated product that shows the effects of our products on indoor air quality.

Composition

Dalsan **ALÇITEK GOLD** is produced from calcium sulphate hemihydrate ($\text{CaSO}_4 \cdot 2\text{H}_2\text{O}$), perlite, filling materials and additives. The distribution of the composition is given in the table on the right.

After production, the final products are packed with polypropylene bags or bigbags. Different packaging materials such as polypropylene and polyethylene can be used as secondary packaging.

The inventory for the LCA study is based on the 2020 production figures for **ALÇITEK GOLD** by DALSAN production plants in Gebze and Ankara, Turkey.


This EPD's system boundary is cradle to grave. The results of the LCA with the indicators as per EPD requirement are given in the following tables for product manufacture (A1, A2, A3), construction process stage (A4, A5), end of life stage (C1, C2, C3, C4) and benefits and load stage (D).

A1: Raw Material Supply

Production starts with raw materials mainly locally sourced but some transported from other parts of the world. 'Raw material supply' includes raw material extraction and pre-treatment processes before production.

A2: Transportation to Production Site

Transport is relevant for delivery of raw materials and other materials to the plant and the transport of materials within the plant. Transport of raw materials to production site is taken as the weight average values for transport from raw materials supplier in 2020.

A3: Manufacturing

Manufacturing starts with stucco preparation (grinding, calcination and separation), Gypsum mineral ($\text{CaSO}_4 \cdot 2\text{H}_2\text{O}$) is grinded and heated to remove 75% of combined water, resulting in the formation of stucco (calcium sulphate hemihydrate) ($\text{CaSO}_4 \cdot \frac{1}{2}\text{H}_2\text{O}$). It is separated depending on the size of powder and mixed with the additives. The end products are then packaged or sold as bulk. Electric energy, natural gas and diesel for generators are consumed during the manufacturing. Part of the electrical energy used is provided by solar panels.

A4: Transport From the Gate to the Site

Transport of final product to construction site is taken as the weight average values for transport to customers in 2020. According to DALSAN sales figures, the transportation distance is assumed as 350 km roadway with a lorry.

A5: Installation

This stage includes the **ALÇITEK GOLD** application on the construction site. For the installation of **ALÇITEK GOLD**, 0.6 L/kg water is used according to the product technical datasheet.

C1 : Deconstruction and Demolition

There is no energy use during uninstallation, manpower and some tools are sufficient.

C2 : Transport

This stage includes the transportation of the discarded plasters to final disposal. Average distance from demolition site to waste processing site for final disposal is assumed to be 100 km.

C3 : Waste Processing

If the wastes are going to landfill or to be inert filler, there is no need for any waste process.

C4 : Disposal

Since gypsum-based plasters cannot be physically separated from the applied surface, they go to the inert waste site with the applied surface or part. For this reason, 100% landfill scenario has been assumed. However, packaging materials can be recycled.

D : Benefits and Loads

In this stage, inert filler benefits and recycling of packaging materials were calculated specified in the disposal stage.

Allocations

Water consumption, energy consumption and raw material transportation were weighted according to 2020 production figures.

In addition, hazardous and non-hazardous waste amounts were also allocated from the 2020 total waste generation.

Cut-Off Criteria

1% cut-off applied. Data for elementary flows to and from the product system contributing to a minimum of 99% of the declared environmental impacts have been included.

REACH Regulation

No substances included in the Candidate List of Substances of Very High Concern for authorization under the REACH regulations are present in this product either above the threshold for registration with the European Chemicals Agency or above 0.1% (wt/wt).

LCA Modelling, Calculation and Data Quality

The results of the LCA with the indicators as per EPD requirement are given in the LCA result tables. All energy calculations were obtained using Cumulative Energy Demand (LHV) methodology, while fresh water use is calculated with selected inventory flows in SimaPro according to the PCR.


There are no co-product allocations within the LCA study underlying this EPD.



